# **AGENCY SPOTLIGHT: GOOD SHEPHERD CENTER**

The Good Shepherd Center, Inc., of Greenville, is one of our 34 member agencies located across Mercer County. The GSC offers a multitude of services. They have a monthly food pantry which serves those in need in the Greenville, and parts of Transfer, and Fredonia areas. They provide emergency food and will, on a client-by-client basis, occasionally aid those in need with utilities.

The GSC also serves hot meals on Monday evenings, and lunches on Tuesdays and Thursdays, at their 10 N. Water Street location and operates a store out of the same location, selling donated clothing and household items. The income generated from the store helps the GSC to purchase food for the pantry, and other operating expenses.

Janet Smith, who took over as Executive Director in December, answered some questions about the Good Shepherd Center.

#### Besides the food pantry, and meals, which services does the Good Shepherd Center currently provide?

We provide over 300 Thanksgiving and Christmas bags, along with Easter baskets to our clients. I don't think enough people are aware of our meals. We provide a hot meal on Monday nights, and lunch on Tuesdays and Thursdays, at our 10 N. Water St. location.

#### How many families do you serve a month, on average?

Around 400.

#### What is your paid staff/volunteer ratio?

Counting myself, we have 2 full time staff, 3 part time staff, and over 200 volunteers. Our volunteers have logged 6036 hours so far this year!

#### You are relatively new to your position- what does it mean to you to be the Executive Director of the Good Shepherd Center?

It's such an honor. I'm amazed at how many people are in need in our area and am grateful to give back and help those people.

#### What are your agency's goals for the future?

I would like to continue to do research into other types of programs that could help the community, and possibly expand our services in the future.

#### How has being a member agency of the Community Food Warehouse helped you?

The CFW is always available and very helpful when I have questions. We appreciate the free produce-the potatoes and onions we received recently were great and you have helped us to get our milk much more cheaply.

#### Is there anything else you would like people to know about the Good Shepherd Center?

One of our part-time staff, Mary Conley, has begun teaching cooking classes to our clients, which are held every other Friday. For our last class, we had 24 adults, which amounts to over 65 hours of class! We're very excited about this program. Interested clients should contact Mary with questions.


### PROGRAM SPOTLIGHT: CSFP (SENIOR FOOD BOX PROGRAM)

The CFWMC's Commodity Supplemental Food Program (CSFP), also commonly known as the Senior Food Box Program, can serve up to 384 seniors at sites across Mercer County. If you or someone you know needs food assistance, now is a great time to contact us and get signed up, as the program does develop a waiting list throughout the year and there are still a few openings now.

About half of the food boxes are delivered to sites throughout Mercer County each month, including Income Assisted High Rises for senior and many of the food pantries who are member agencies of the CFW. The other half of the boxes are distributed each month at the CFWMC in a kind of "drive thru." Seniors simply sign for their food box and drive away with the food in their car. The Senior Food Box program alleviates some of the financial burden on our pantries.

An army of volunteers makes the CSFP program function! From packing the food boxes once a month on a Tuesday evening, to delivering boxes throughout the month to the Senior High Rises, volunteers make it possible to provide nutritious food to seniors in need in Mercer County. # ADVOCACY: NUTRITIOUS FOOD FOR FAMILIES STARTS WITH STRONG FARM BILL

Congress has left for their summer recess. This is a great time to engage them as they continue their work to re-authorize the farm bill, the major federal agriculture and nutrition legislation. The farm bill contains important nutrition programs like the Supplemental Nutrition Assistance Program (Snap, sometimes called food stamps) and The Emergency Food Assistance Program (TEFAP and gets reauthorized every five years. The next farm bill expires in September of 2018 but Congress has started working on the legislation already and now is the time to make sure our priorities for the bill are heard. Snap is the largest anti-hunger program in the Untied States. It serves 1,863, 800 people in Pennsylvania, roughly 67 % are children and seniors. With SNAP, we would be overwhelmed by need.

TEFAP provides food banks like us with healthy food that we distribute to our agencies. TEFAP provides Pennsylvanian with 26, 184, 973 pounds, 263, 267 if which go to the CFWMC. This is some of the healthiest food available to families facing hunger, with the USDA rating it healthier than the typical American diet.

Community Food Warehouse, in partnership with Feeding America, wants to find way to make these nutrition programs working better in the next farm bill. We hope you will join us in fighting for strong anti-hunger programs. Here are three ways that you can get involved:

- Tell your lawmaker you think hunger in your community is unacceptable: Share the facts above with your lawmaker and ask them to support a strong farm bill that ensures federal nutrition programs works for everyone in your community.
- Post on social media: Facebook and Twitter can be used to get the word out about how important it is to keep antihunger programs strong. A quick post can let your followers and friends know that you care abo the farm bill and strong anti-hunger programs.
